Since its formation in 1979, NAWJ has fought to preserve judicial independence, to ensure equal justice and access to the courts for women, minorities, and other historically disfavored groups, to achieve fairness and equality for vulnerable populations, to increase the numbers and advancement of women judges at all levels, and has worked to provide cutting-edge judicial education. From the day it was founded, NAWJ has been committed to diversity in our membership. Our organization welcomes both men and women. Our membership includes trial and appellate, administrative, tribal and military judges, on federal, state and tribal courts at every level of the judiciary, from throughout the country.
